



PARTNERSHIP PROVISION TERMS AND CONDITIONS

- AGREEMENT: By accepting an offer of a place to study on your course, you are entering into an agreement with Cornwall College ("the College") and Falmouth University ("the University"). Your offer letter, these standard terms and conditions and the documents referred to herein constitute your agreement with the College and the University.
- 1.1 The College is a further education provider that offers courses and qualifications sited within the UK frameworks for further and higher education qualifications.
- 1.2 The University is a UK higher education institution with the power to award degrees, diplomas, certificates and other academic distinctions up to the level of taught Master's in accordance with its Articles of Government.
- 1.3 Further to your acceptance of the offer outlined in (1), you will be asked to enroll and register as a student of the College. Upon enrolment you will be asked to accept the regulations, policies, and procedures of the College, which can be accessed https://www.cornwall.ac.uk/university-hub/. - 1.4 The University is the recognised awarding body for your degree course. This means that the credit you accumulate on your course is awarded by Falmouth University, and, that, subject to the successful completion of your course, you will graduate with a Falmouth University degree.
- 1.5 By enrolling with the College, you also agree to accept Falmouth University's Academic Regulations, including the University's Academic Integrity Policy, and Extenuating Circumstances Policy. These important documents set out the rules governing your academic progression, retrieval opportunities, and degree classification. You should be aware that, whilst you will be subject to University policy relating to your academic progression, any procedural action may be undertaken by College staff in equivalent and/or similar roles to those outlined in the University's procedures. Where procedural action is required, College staff will work in accordance with the relevant University policy.

- 1.6 If you believe that there has been a material error or irregularity in the assessment process, you should lodge an appeal with Falmouth University. The University's Appeals Policy and Procedure can be accessed here: (www.falmouth.ac.uk/studentregulations)
- 1.7 Policies and regulations are updated and reproduced annually, and may be subject to modifications during the academic year. You will be notified of any changes by email to your College email account.
- 2. **OFFER CONDITIONS:** Where places are conditional according to the terms in your offer letter, the College reserves the right to withdraw the offer of a place in the event that you fail to meet these conditions.
- 3. DATA PROTECTION AND DISCLOSURE OF PERSONAL INFORMATION: The application procedure, registration and enrolment, and your academic progress will provide the College with a range of information about you. The College will use this to support you on your student journey and for the administration and management of the College, including statistical analysis. Some information may be shared between the College and the University, including, but not limited to, the following:
 - i. your assessment marks and progression status for the purposes of confirming academic progression at Assessment Boards and issuing degree certificates;
 - ii. your enrolment and registration status at the College, such that the University can complete its statutory returns;
 - iii. information that may be relevant to the investigation and/or review process if you lodge an appeal against the outcome of an Assessment Board, or if you make a complaint about academic standards on your course.
- Further, some of this information may be disclosed outside of the College and the University, either at your request or in your interest, including, but not limited to, the following:
 - i. data that is necessary for completing statutory returns to funding bodies, such as the Higher Education Funding Council for England (HEFCE);
 - ii. data that enables provision of specific needs support (if required), where the service is provided by a third party.
- 3.2 Both the College and the University undertake to ensure that your data are managed in accordance with relevant Data Protection legislation and that any "sensitive data" are treated confidentially and in accordance with the Data Protection Act 2004.

- **4. ENTITLEMENTS:** as a student registered for a Falmouth University award, you will be entitled to access:

 - ii. Graduation costs
 - iii. National Union of Students card (NUS card)

- 5. PARTNERSHIP CONTRACT: The partnership agreement between the College and the University is due for review and renewal by September 2021. In the event of non-renewal, the University and the College commit to ensuring that all currently enrolled students are given the opportunity to complete their degree course or equivalent qualification.
