## Questions in the application form

#### Do Student Finance consider you 'independent' of your parents?

Student Finance will consider a student 'independent' of their parental home(s) if they are, on the 1<sup>st</sup> Sept in the academic year they access support:

- Aged 25 or over
- Are married
- Are the primary carer for a dependent child
- Have been financially independent for at least 36 months (3 years), prior to commencing their studies
- Are permanently estranged from both parents or are orphaned

Such circumstances will need to have been evidenced to Student Finance as part of a claim for 'independent status'. If Student Finance regards a student as not being 'independent' then it will be expected that their household will make an appropriate contribution towards maintenance costs.

#### Do you live with your partner?

This means that you and your partner share your accommodation. If you live in a shared house (multiple occupancy), you do not need to complete this section.

#### If you do live with your partner, please clarify their situation

In order to fully understand your domestic financial situation, we need to know some details about your partner, if you live with them. Firstly; by understanding their full-time situation, the Panel can assume how they should be funding themselves.

# If you live with your partner, please detail how they contribute towards your domestic bills and rent

It will be assumed that your partner will be accessing the relevant income associated with their situation:

- Full-time students should be accessing support from Student Finance and/or their parents
- Unemployed non-students should be accessing the appropriate state benefits
- Employed non-students should be receiving a salary
- Other; If none of the above categories fairly reflect your partners situation, please detail this here, or in more depth in your Supporting Statement (under the 'Supporting Documentation' section)

The Panel would not expect the student to be paying for more than 50% of domestic bills or have their partner financially dependent upon them.

#### During term time, what are your accommodation arrangements?

Are you living with your parents; in Halls; or in a private house? This information will help inform the Panel as to what your domestic costs are likely to be.

#### Do you have any dependants (children or adult, who are financially dependent on you)?

Dependents include any children for whom you receive Child Benefit and/or adults for whom you receive Adult Dependent Grant from Student Finance.
